

## **Information on the Processing of Personal Data for the purpose of Sending Newsletters**

According to Articles 13 and 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council on the Protection of Natural Persons with regard to the Processing of Personal Data and on the Free Movement of Such Data (hereinafter referred to as the “GDPR Regulation”) and §§ 19 and 20 of Act No. 18/2018 Coll. on the Protection of Personal Data and on the Amendment and Supplementation of Certain Acts (hereinafter referred to as the “Data Protection Act”).

### **Rights of the Data Subject**
